

MINUTES OF THE LEE COUNTY COMMISSION, REGULAR TERM, FEB. 9, 2026

The Lee County Commission convened in regular session at the Courthouse in Opelika, Alabama, on Monday, Feb. 9, 2026, at 5:00 p.m. The Pledge of Allegiance was recited, followed by the invocation by Judge Colley.

Chairman Judge Jere Colley declared a quorum and officially opened the meeting with the following members recorded as being present: Commissioners Doug Cannon, Ross Morris, Jeff Drury, Tony Langley, and Richard LaGrand.

James Hardin from the Lee County Health Department thanked the Commission for its support and notified the Commission that renovations have begun on its building.

Lakeshia Hicks-Young notified the Commission that the Internet has finally reached her road with a few minimal issues which are being looked at. She also asked for support regarding speeders at the Loachapoka Community Park area.

Judge Colley recognized the elected officials in attendance: Sheriff Jay Jones. News media in attendance included: None.

Commissioner Morris invited everyone to the Courthouse Historic Marker Re-dedication on Sunday, March 1, at 2 p.m.

Commissioner LaGrand complimented the Highway Department for the work it is doing on the roundabout at Moore's Mill Road.

Copies of the items on the Consent Agenda sent to the Commissioners in their packets included: listings of claims to be approved and ratified, procurement card transactions listing, and a copy of the minutes from Jan. 26, 2026. In addition, an announcement was made of an opening on the Lee County Alternative Sentencing Board. Commissioner Cannon made a motion, seconded by Commissioner Morris to approve the consent agenda. The motion carried unanimously. See attachment.

Lance Farrar presented concerns regarding the Solid Waste Plan. He presented a timeline of various actions taken since 2021 regarding the development of curbside garbage service, the closing of dumpsters and the abolishing of bulk pickup routes which he stated negatively affected the citizens of the county. Mr. Farrar also discussed concerns with various public records requests he has submitted to the Commission Office since 2023.
