

MINUTES OF THE LEE COUNTY COMMISSION, REGULAR TERM, JUNE 8, 2026

The Lee County Commission convened in regular session at the Courthouse in Opelika, Alabama, on Monday, June 8, 2026, at 5:00 p.m. The Pledge of Allegiance was recited, followed by the invocation by Commissioner Morris.

Commissioner Doug Cannon, serving as vice-chair, declared a quorum and officially opened the meeting with the following members recorded as being present: Commissioners Doug Cannon, Ross Morris, Jeff Drury, Tony Langley, and Richard LaGrand. Chairman Judge Jere Colley was not present.

John Sophocleus spoke about the results of the recent primary election.

Jeff Monroe introduced himself as a runoff candidate for State House District 37.

Commissioner Cannon recognized the elected officials in attendance: Sheriff Jay Jones and District Attorney Jessica Ventiere. News media in attendance included: Hannah Goldfinger with the Opelika Observer.

Copies of the items on the Consent Agenda sent to the Commissioners in their packets included: listings of claims to be ratified, procurement card transactions listing, and a copy of the minutes from May 26, 2026. Commissioner Morris made a motion, seconded by Commissioner Langley, to approve the consent agenda. The motion carried unanimously. See attachment.

Commissioner LaGrand requested to add an item to the agenda. Commissioner Drury made the motion, seconded by Commissioner Morris to amend the agenda. The motion carried unanimously. Commissioner LaGrand commended Alpha Kappa Alpha Sorority, Inc., for its recent senior community day; Heritage House on its car show; Grandma Val's lemonade on its fifth year in business; the Spencer Cancer Center for its survivor picnic at Spring Villa and reminded everyone of the upcoming Juneteenth Holiday.

The first reading for an opening on the Communications District (E-911) Board was held. As more than one citizen expressed interest, Commissioner Drury made a motion to recommend Blake Green for the position. The motion was seconded by Commissioner Morris and carried on a 4-0-1 vote with Commissioner Langley abstaining. See attachment.

Chief Operating Officer Blake Beck presented a Budget Adjustment request for \$148,412 to fully fund the EMS Contract. Commissioner Morris made a motion, seconded by Commissioner LaGrand, to approve the request. The motion carried unanimously. See attachment.

At approximately 5:14 p.m., Commissioner Morris made a motion, seconded by Commissioner Langley, to adjourn. The motion carried unanimously.
